### **TANYA MARIE BRYANT ADOPTION TERMINATION ACT**

*(Assented to , 1998)*

Preamble

WHEREAS by order of His Honour Judge H. S. Patterson in the District Court of Southern Alberta, Judicial District of Calgary, it was ordered that Tanya Lorraine Owen be declared to be, from and after April 12, 1965, the adopted child of Lloyd Christian Nygaard and Gunnhild Karoline Nygaard and be given the name Tanya Marie Nygaard;

WHEREAS by order of His Honour Judge C. G. Yanosik in the District Court of Southern Alberta, Judicial District of Medicine Hat, it was ordered that Tanya Marie Nygaard be declared to be, from and after April 12, 1972, the adopted child of Raymond Douglas Stafford and Gunnhild Karoline Stafford and be given the name Tanya Marie Stafford;

WHEREAS the adoption orders can no longer be appealed against by reason of the lapse of time;

WHEREAS the Petitioner, Tanya Marie Bryant, applied for and was granted a change of maiden surname to Tanya Marie Lowry pursuant to the *Change of Name Act* on March 14, 1996; and

WHEREAS the Petitioner has presented a petition that it be enacted as herein set forth and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

**1(1)** The order dated April 12, 1965, and entered on April 13, 1965, whereby Tanya Lorraine Owen was declared to be the adopted child of Lloyd Christian Nygaard and Gunnhild Karoline Nygaard and to be named Tanya Marie Nygaard is hereby terminated.

**(2)** The order dated and entered on April 12, 1972, whereby Tanya Marie Nygaard was declared to be the adopted child of Raymond Douglas Stafford and Gunnhild Karoline Stafford and to be named Tanya Marie Stafford is hereby terminated.

**2** Tanya Marie Bryant is hereby declared not to be the lawful child and heir of

- (a) Lloyd Christian Nygaard,
- (b) Raymond Douglas Stafford, or
- (c) Gunnhild Karoline Stafford, previously known as Gunnhild Karoline Nygaard,

and not to have any rights of inheritance from any of the persons outlined in clauses (a) to (c) that might otherwise devolve on her by law.
