PROFESSIONAL STATUTES AMENDMENT ACT, 2010

(Assented to , 2010)

HER MAJESTY, by and with the advice and consent of the
Legislative Assembly of Alberta, enacts as follows:

Agrology Profession Act

Amends SA 2005 cA-13.5

1(1) The *Agrology Profession Act* is amended by this section.

(2) Section 105 is amended by striking out “of Human Resources and Employment and the Minister of Advanced Education” **and substituting** “and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act*”.

Architects Act

Amends RSA 2000 cA-44

2(1) The *Architects Act* is amended by this section.

(2) The following is added after section 10:

Consultation with Ministers required

10.1 Before the Council, by regulation, establishes or amends the academic qualifications and training requirements for applicants for registration as registered architects and licensed interior designers, the Council must consult with the Minister

Explanatory Notes

Agrology Profession Act

1(1) Amends chapter A-13.5 of the Statutes of Alberta, 2005.

(2) Section 105 presently reads:

105 Before the Institute approves or removes the approval from a program of study or an education course under section 3(2), the Institute must consult with the Minister of Human Resources and Employment and the Minister of Advanced Education and must consider the comments received from those Ministers.

Architects Act

2(1) Amends chapter A-44 of the Revised Statutes of Alberta 2000.

(2) Consultation with Ministers required.

and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act* and must consider the comments received from those Ministers.

Engineering, Geological and Geophysical Professions Act

Amends RSA 2000 cE-11

3(1) The *Engineering, Geological and Geophysical Professions Act* is amended by this section.

(2) The following is added after section 20:

Consultation with Ministers required

20.1 Before the Council, by regulation, establishes or amends the academic qualifications for applicants for registration as professional engineers, geologists or geophysicists, the Council must consult with the Minister and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act* and must consider the comments received from those Ministers.

(3) The following is added after section 87.4:

Consultation with Ministers required

87.41 Before the ASET Council, by regulation, establishes or amends the academic qualifications for applicants for registration as regulated members, the Council must consult with the Minister and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act* and must consider the comments received from those Ministers.

(4) The following is added after section 88.5:

Consultation with Ministers required

88.51 Before the JPT Regulations Committee, by regulation, establishes or amends the academic qualifications for applicants for registration as professional technologists, the Council must consult with the Minister and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act* and must consider the comments received from those Ministers.

Land Surveyors Act

Amends RSA 2000 cL-3

4(1) The *Land Surveyors Act* is amended by this section.

Engineering, Geological and Geophysical Professions Act

3(1) Amends chapter E-11 of the Revised Statutes of Alberta 2000.

(2) Consultation with Ministers required.

(3) Consultation with Ministers required.

Land Surveyors Act

4(1) Amends chapter L-3 of the Revised Statutes of Alberta 2000.

(2) The following is added after section 17:

Consultation with Ministers required

17.1 Before the Council, by regulation, establishes or amends the academic qualifications and training requirements of applicants for registration as Alberta land surveyors, the Council must consult with the Minister and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act* and must consider the comments received from those Ministers.

Professional and Occupational Associations Registration Act

Amends RSA 2000 cP-26

5(1) The *Professional and Occupational Associations Registration Act* is amended by this section.

(2) The following is added after section 15:

Consultation with Ministers required

15.1 Before the governing body of a registered association, by regulation, establishes or amends the eligibility requirements that relate to the academic qualifications of applicants for membership in the registered association, the governing body must consult with the Minister and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act* and must consider the comments received from those Ministers.

Regulated Accounting Profession Act

Amends RSA 2000 cR-12

6(1) The *Regulated Accounting Profession Act* is amended by this section.

(2) The following is added after section 15:

Consultation with Ministers required

15.1 Before a governing body, by regulation, establishes or amends the education requirements for registration as a chartered accountant, certified general accountant, certified management accountant or student, the governing body must consult with the Minister and the Minister responsible for Parts

(2) Consultation with Ministers required.

**Professional and Occupational
Associations Registration Act**

5(1) Amends chapter P-26 of the Revised Statutes of Alberta
2000.

(2) Consultation with Ministers required.

Regulated Accounting Profession Act

6(1) Amends chapter R-12 of the Revised Statutes of Alberta
2000.

(2) Consultation with Ministers required.

Regulated Forestry Profession Act

Amends RSA 2000 cR-13

7(1) The *Regulated Forestry Profession Act* is amended by this section.

(2) Section 101.1 is amended by striking out “of Human Resources and Employment and the Minister of Learning” **and substituting** “and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act*”.

Veterinary Profession Act

Amends RSA 2000 cV-2

8(1) The *Veterinary Profession Act* is amended by this section.

(2) The following is added after section 14:

Consultation with Ministers required

14.1 Before the Council, by regulation, establishes or amends the academic qualifications of applicants for registration as registered veterinarians, the Council must consult with the Minister and the Minister responsible for Parts 1 to 3 of the *Post-secondary Learning Act* and must consider the comments received from those Ministers.

Regulated Forestry Profession Act

7(1) Amends chapter R-13 of the Revised Statutes of Alberta 2000.

(2) Section 101.1 presently reads:

101.1 Before a college approves or removes the approval from a program of study or an education course under section 3(1.1), the college must consult with the Minister of Human Resources and Employment and the Minister of Learning and must consider the comments received from those Ministers.

Veterinary Profession Act

8(1) Amends chapter V-2 of the Revised Statutes of Alberta 2000.

(2) Consultation with Ministers required.
