### **Public Meetings Scheduled for the Review of Bill 9 and Bill 10 (Pension Reform Bills)**

EDMONTON –The all-party Standing Committee on Alberta’s Economic Future is undertaking a review of Bill 9, *Public Sector Pension Plans Amendment Act, 2014*, and Bill 10, *Employment Pension (Private Sector) Plans Amendment Act, 2014*.

“This is an issue that is important to many Albertans and we want to hear their input,” said Moe Amery, MLA for Calgary-East and chair of the Standing Committee on Alberta’s Economic Future. “We have scheduled public meetings across the province and invite Albertans to attend and make their views known.”
