II. INTRODUCTION

The Standing Committee on Public Accounts is composed of 12 Members and comprises a Chair, who is a Member of the Official Opposition (New Democratic - NDP), and a Deputy Chair, who is a Member of the Government caucus (United Conservative - UC). The composition of the remaining 10 members is approximately proportionate to the number of seats held by the NDP and UC in the Legislative Assembly of Alberta.

The mandate of the Standing Committee on Public Accounts is to review the public accounts of the province of Alberta and ministry annual reports through the process of asking questions with respect to the expenditures of Government departments and the Auditor General's reports. Pursuant to Standing Order 53(1) the public accounts and all reports of the Auditor General stand permanently referred to the Committee.

The public accounts of Alberta are prepared in accordance with the *Financial Administration Act* and the *Fiscal Management Act*. The public accounts consist of the annual report of the Government of Alberta and the annual reports of each of its ministries.

The 2020-2021 annual report of the Government of Alberta contains Budget 2020 Key Results, the audited Consolidated Financial Statements and *Performance Results*, which compares actual performance results to desired results set out in the Government's strategic plan.

The annual reports for the ministries for the year ended March 31, 2021, contain ministers' accountability statements, the audited consolidated financial statements of the ministries, and a comparison of actual performance results as well as the desired results set out in the ministries' business plans.

The reports of the Auditor General include annual reports and special reports. Annual reports provide audit findings and include recommendations for the improvement of controls and processes within Government and the issuance of audit opinions on the financial statements of ministries, agencies, boards, and commissions. Special reports of the Auditor General are prepared on any matter of importance or urgency that the Auditor General believes should not be deferred until the presentation of the annual report.

MANDATE AND SCOPE III.

The mandate of the Public Accounts Committee includes reviewing and reporting on the public accounts of Alberta, all reports of the Auditor General of Alberta, and other matters that may be referred to the Committee by the Assembly. Its mandate extends to all public entities funded by Government, including agencies, boards and commissions. All reports of the Auditor General stand permanently referred to the Public Accounts Committee.

The Committee calls on senior department officials and/or officials of agencies, boards, and commissions and such others as may be necessary to fulfill its mandate.

The Committee sets its own agendas and may sit whether or not the Assembly is in session. The Committee may report to the Assembly on a particular matter or generally with respect to its body of work, and the Government shall respond to a substantive report of the Public Accounts Committee within 150 days of the date on which the Committee reports.

IV. **ACTIVITIES OF THE COMMITTEE**

In the winter of 2021, prior to the commencement of the 2021 spring sitting, the Committee met two times. During the 2021 spring sitting of the Second Session of the 30th Legislature the Committee met nine times. The Committee also met on September 17, 2021, when the Assembly was not in session, to discuss scheduling for the Fall 2021 Sitting. The Committee held six meetings during the 2021 fall sitting, including one session with the Auditor General on December 14, 2021.

The Subcommittee on Committee Business met four times during this reporting period to discuss and recommend schedules for meetings with ministries, including agencies, boards, and commissions reporting to the ministries, and to highlight any potential issues of interest for the Committee. The Subcommittee also discussed planning for the 2021 annual conference of the Canadian Council of Public Accounts Committees and Canadian Council of Legislative Auditors.

Committee Research Services and the Office of the Auditor General continued to provide oral and written research briefings for caucus research staff and committee members.

From September 8 to 9, 2021, the Committee co-hosted the annual conference Canadian Council of Public Accounts Committees and Canadian Council of Legislative Auditors with the Alberta Office of the Auditor General. Due to the COVID-19 pandemic, the conference was held primarily online, although some Alberta delegates attended in-person. There were 132 delegates who registered for the conference, coming from every province, the House of Commons Standing Committee on Public Accounts and two of the three territories. The delegates included Public Accounts Committee members, committee staff, Auditors General, and audit staff. The theme of the conference dealt with the work of Public Accounts Committees and Auditors General in a COVID and post-COVID world.

CANADIAN COUNCIL OF PUBLIC ACCOUNTS COMMITTEES (CCPAC) VI. AND CANADIAN COUNCIL OF LEGISLATIVE AUDITORS (CCOLA) CONFERENCE

Joint conference of Canadian Council of Public Accounts Committees (CCPAC) and Canadian Council of **Legislative Auditors (CCOLA)**

At the Canadian Council of Public Accounts Committee and Canadian Council of Legislative Auditors 2019 annual conference, it was confirmed that Alberta's Public Accounts Committee and Office of the Auditor General would co-host the 2021 annual conference. The Chair of the Standing Committee on Public Accounts and the Auditor General of Alberta confirmed in February 2021 that due to the COVID 19 pandemic the conference would be held virtually.

The theme of the conference dealt with the work of Public Accounts Committees and Auditors General in a COVID and post-COVID world. The conference consisted of a jurisdictional update, three business sessions, and a round-table of Information and Privacy Commissioners, led by Information and Privacy Commissioner of Alberta Jill Clayton, discussing privacy issues in a COVID and post-COVID world. The conference concluded with the annual meetings of the Canadian Council of Public Accounts Committees and the Canadian Council of Legislative Auditors along with a breakout session consisting of Committee Clerks and Committee Researchers who work with Public Accounts Committees from across Canada.

The conference engaged Edmonton-based Mr. André Beauregard, and his colleagues, to deliver simultaneous interpretation of conference programming in both English and French via Microsoft Teams and utilizing Interprefy, a Swiss-based online simultaneous interpretation software company. Two keynote speakers, author André Picard and Dr. Lindsay Tedds from the University of Calgary, provided online presentations to delegates. Rapid Fire Theatre of Edmonton was able to provide an improvised theatre performance to delegates as part of the conference social program.

As the conference was delivered entirely online, there was no opportunity for receptions or conference dinners. Instead, the planning group for the conference sent out pre-packaged gift boxes to registered delegates, containing Alberta-made products, creative works from Alberta artists, links to virtual tours of Alberta attractions, and a copy of André Picard's book, Neglected No More: The Urgent Need to Improve the Lives of Canada's Elders in the Wake of a Pandemic.

Each jurisdiction's Public Accounts Committee and Auditor General Office were allotted four no-cost registration spots for delegates. Additional delegates could register for the conference for a fee of \$50 per delegate.
