### 1. Question from Mr. Thomas Dang (NDP), MLA for Edmonton-South

### **Investing in Canada Infrastructure Program (ICIP)**

"I understand that a number of the projects were continued and approved under the ICIP, but a number of projects, such as the Lethbridge performing arts centre, didn't move forward in the process. Could you get us a list of those projects and how many dollars didn't move forward?" (Page PA-217)

### **Deputy Minister's Response:**

"We can provide you with the list of the complete 700 applications and then the list that did get approved."

# **Supplemental Response:**

- As part of Budget 2020, the Province has endorsed more than 70 projects in more than 30 constituencies to move forward to the federal application stage. Applicants with endorsed projects are working with the Province to fulfill the federal application requirements. Under the terms of the Integrated Bilateral Agreements, project announcements can only be made jointly once federal approval is received.
- 13 projects were previously approved for \$2.7 billion in ICIP funding (see Attachment 1 – ICIP Federally Approved Projects):
  - 1. Alberta Capital Region Wastewater Commission Waste Gas Burner Facility
  - 2. Ben Calf Robe School Building Upgrades (Edmonton)
  - 3. Green Line LRT (Calgary)
  - 4. Edmonton Valley Line West LRT (Edmonton)

  - 6. New Mechanical Expansion at Wastewater Treatment Facility (Lloydminster)

  - 10. Interfaith Foodbank Building Upgrades (Lethbridge)

  - 13. YWCA Calgary Hub Facility Project (Calgary)

### 2. Question from Mr. Thomas Dang (NDP), MLA for Edmonton-South

### **Edmonton Clinical Laboratory Hub**

"I understand that I think it was about \$23 million that was spent on the project in terms of construction that had been started. Can you tell the committee perhaps at least as of March 31 how much money was spent cancelling the project? What does the amount include, what does it exclude. In terms of external costs to the ministry, how much does the remediation cost? How much do the termination of contracts cost? Those kinds of numbers." (Page PA-217)

### **Supplemental Response:**

- It is anticipated it will cost a total of \$35.5 million to close out and restore the site, including the costs incurred prior to termination.
- The costs for the Edmonton Clinical Laboratory Hub project include the following:
  - \$22.6 million was spent in capital investment for the project prior to the cancellation date. This includes funding for design and construction activities.
  - o In addition to the capital investment that was written off it is expected that a further \$12.9 million will be expensed. A total of \$9.8 million was expensed in 2019-20 as part of the settlement with the consultants and construction manager. It is anticipated a further \$3.1 million will be expensed in 2020-21 for project close out and site restoration in accordance with Occupational Health and Safety standards.

### 3. Question from Mr. Jason Stephan (UCP), MLA for Red Deer-South

# Jurisdictional Comparison – Cost to Deliver Comparable Infrastructure Capital Projects

"In terms of the budgets that have been set for infrastructure projects, do we have tools to compare how the private-sector costs would be to complete a comparable project? ... How do we compare to the other provinces?" (Page PA-220)

### **Deputy Minister's Response:**

"It's difficult to do that because, particularly for hospitals and schools, it's primarily governments that actually build those. We could do a comparison, I guess, of projects that were built, for instance, by Infrastructure Ontario or the B.C. government in terms of some of the projects that we do build. It would be hard to get that comparison from the private sector because they typically don't build or tender hospitals or schools.

...I'd be happy to actually bring that information back to you. We've done it, actually, for capital maintenance and renewal, and we know that we're very competitive in that."

#### **Supplemental Response:**

- Infrastructure completed an assessment of facilities management costs relative to other jurisdictions. The consultants that completed the assessment concluded that, on a per square metre basis, Infrastructure's cost to operate its real estate portfolio is lower than other jurisdictions.
- Infrastructure does not currently have a comparison to the private sector of costs
  to deliver capital maintenance and renewal projects; however, the
  MacKinnon Panel report includes a recommendation (Recommendation 14) to
  look at greater coordination, in part to stabilize and rationalize the allocation of
  capital maintenance and renewal spending and give priority to areas of greatest
  need across all government assets.
- Infrastructure is conducting a review of capital maintenance and renewal with a view to establishing a new funding profile.
- The work will result in best practice management of capital maintenance and renewal for Alberta which will provide value in a number of ways, including avoiding expensive emergency repairs and addressing the highest priority needs.

### 4. Question from Mr. Pete Guthrie (UCP), MLA for Airdrie-Cochrane

"On page 12 of the annual report it states that 30 schools were built in '18-19. I know you mentioned it in your intro, but can you tell us again: how many are currently under way, including construction, design, and planning, and what would be the split between Infrastructure-built projects and school board built projects?"

(Page PA-220)

### **Deputy Minister's Response:**

"There are 74 active school projects under way as of April 30, 2020: 50 are in planning, design, tender, or contract award; 14 of those are in construction and expected to open by the end of this year; and then 10 are in construction and expected to open by the end of 2021. I can provide you with a list if you'd like that, Member.

As well, out of the 74 active school projects, 51 are Infrastructure-managed projects. The ministry manages the projects from design to construction and warrantee phase. Twenty-two are school jurisdiction managed projects, grant-funded projects for jurisdictions to contract and manage building design and construction work, and one project is yet to be determined in terms of the delivery method. I'm happy to provide you, again, with that list of schools as well in terms of 51 versus 22."

#### **Supplemental Response:**

More recent information as of May 31, 2020 is now available and provided below.

There are 71 active school capital projects underway (three of these were completed since June 2, 2020):

- 48 are in planning, design, tender, or contract award;
- 13 are in construction and expected to open by the end of 2020; and
- 10 are in construction and expected to open by the end of 2021 and beyond.

5. Question from Ms. Sarah Hoffman (NDP), MLA for Edmonton-Glenora

Job Creation – Complex Continuing Care (Bridgeland) and Gene Zwozdesky Centre at Norwood (Norwood)

"Could you tell us...how many jobs those two projects were creating in 2018-19, and where they're at today"? (Page PA-223)

### **Supplemental Response:**

- The total number of jobs created by construction of the Complex Continuing Care (Bridgeland) project (in Calgary) is 520.
- Design and construction activities for the Gene Zwozdesky Centre at Norwood occurred in two calendar years. In the latter part of 2018, over 50 positions were required and in early 2019 that number had grown to over 90 positions. The actual number of people working on the project varies on a day-to-day basis.

# 6. Question from Ms. Sarah Hoffman (NDP), MLA for Edmonton-Glenora

### **Deferred Maintenance and Strategy**

"If that assessment and the breakdown [for deferred maintenance] could be shared with us in writing, that would be helpful to me. And if you want to include the strategy on how to address that moving forward, too, that would – you've mentioned that we have a pretty strict strategy and investment plan, so if you could table some of that in writing, that would also be helpful." (Page PA-224)

### **Supplemental Response:**

- The total deferred maintenance for government-owned facilities, health facilities, school facilities, and post-secondary institutions is approximately \$2.6 billion. This includes the following as of March 31, 2019. Figures reflect infrastructure supported facilities only.
  - \$0.5 billion for government facilities
  - o \$0.5 billion for health facilities
  - \$0.7 billion for school facilities
  - o \$0.9 billion for post-secondary institutions
- A consistent methodology is applied based on the nature of the assets across all government facilities, and is based on facility evaluations completed by Infrastructure.
- Deferred maintenance amounts do not indicate the amount of investment required in facilities, but is used as a measure to highlight areas of concern. The Asset Management Strategy considers the long-term plans for facilities when making investment decisions. Other factors impacting maintenance decisions include the asset condition, safety, service standards, functionality, capacity, and efficiency.
- Annual capital maintenance and renewal funding are allocated to each of these envelopes in the Capital Plan.
  - Infrastructure holds the maintenance and renewal budget related to government-owned facilities, health facilities, and school facilities delivered under public-private partnership contracts.
  - Education and Advanced Education hold the maintenance and renewal budgets related to school facilities (except for public-private partnerships) and post-secondary institutions.
- Infrastructure has developed criteria to assess maintenance priorities across its government-owned asset portfolio.
- One of the MacKinnon Panel recommendations (Recommendation 14) is look at greater coordination, in part to stabilize and rationalize the allocation of capital maintenance and renewal spending and give priority to areas of greatest need across all government assets.
- Infrastructure is conducting a review of capital maintenance and renewal with a view to establishing a new funding profile.

• The work will result in best practice management of capital maintenance and renewal for Alberta which will provide value in a number of ways, including avoiding expensive emergency repairs and addressing the highest priority needs.

# 7. Question from Ms. Sarah Hoffman (NDP), MLA for Edmonton-Glenora

#### **Asbestos**

"I'm wondering if asbestos is factored into that or if asbestos abatement is a separate assessment and if we have any kind of measure or estimate as to what our asbestos abatement cost would be in the province if we had to do it.

...Whatever information we do have I think would be useful for us, to know what our risk mitigation is there." (Page PA-224)

### **Deputy Minister's Response:**

"...when we go in to actually do buildings, unfortunately we don't actually always know if asbestos is contained. We can kind of tell it by the year. So it will depend from building to building."

# **Supplemental Response:**

- Assessments are required in order to obtain an accurate inventory of hazardous materials (including asbestos); this information then becomes part of hazardous materials management plans for each facility delineating not only the locations for these materials, but also action plans for maintenance as well as potential emergent situations.
- In the absence of completing a formal assessment, the age and type of facility help identify likelihood of hazardous materials presence and any potential risks that might be posed.

# Number of Jobs – Edmonton Clinical Laboratory Hub and Infrastructure Projects

"...I'd like to know how many jobs were active at the time that the [lab hub] project was shelved and what the projected job count was for that initiative and then also the rolled-up numbers for infrastructure jobs during the '18-19 fiscal year ...could we get a rolled-up job count for the '18-19 fiscal year, please?" (Page PA-224)

# Supplemental Response:

- Cancellation of the Edmonton Lab Hub occurred in June 2019. The total number of jobs that were active at cancellation was approximately 215.
- The overall rolled-up number of jobs for all Infrastructure capital projects in 2018-19 was approximately 6,000.

# 10. Question from Ms. Marie Renaud (NDP), MLA for St. Albert

# **Michener Centre Complex (Red Deer)**

"My question is about the Michener Centre complex in Red Deer. As far as I understand, it's about 360 acres, with close to 70 buildings on-site, things like an aquatic centre, a medical centre. In its heyday it was serving several thousands of people; now it's just over a hundred people. I'm wondering if it's possible to get a breakdown of the buildings that are on that piece of land in terms of disposal plans, maintenance planning, and also just the condition index, if your department could provide us with a rating on the major buildings on that site." (Page PA-229)

### **Supplemental Response:**

- Michener Centre includes both the north and south sites.
- Michener North:
  - Michener North was operated by Community and Social Services (CSS) -Persons with Developmental Disabilities until 2014 when remaining residents were relocated to Michener South.
  - The site is vacant except for a lease of a portion with a non-government user.
  - Michener North has 31 buildings, all of which have been decommissioned.
    They include a range of buildings that originally supported the program, as well
    as buildings tied to operation and maintenance. The buildings are currently
    unfit for occupancy and in poor condition, which equates to a facility condition
    index of zero.
  - Infrastructure has plans for the abatement and demolition of the north site buildings.
  - There is limited ongoing maintenance which mostly includes minimal grounds and snow removal work.
  - A safety fence was installed in 2016 encompassing buildings on the site, to minimize the ongoing risk of hazardous materials exposure, vandalism and trespassing.
- Michener South:
  - Michener South remains an active program site for CSS.
  - There are 63 buildings in total on the site. They include a range of buildings to support the CSS program and Infrastructure's operation and maintenance of the site.
  - Preventative maintenance and repairs are ongoing activities.
  - Of the 63 buildings, two have been decommissioned. The majority of the buildings are in fair condition.

### 11. Question from Mr. Lorne Dach (NDP), MLA for Edmonton-McClung

### **Space Reduction Policy**

"Given that Deputy Minister Flint has mentioned that they were doing more with less space, I was wondering if in 2018-19 that policy to reduce the space per employee included a consideration for the health implications of that reduced space, perhaps with tighter quarters resulting from that policy, if physical distancing was something that was a thing back in that period of time, and if those health considerations are something we should be looking at, going forward, when we look at that this policy of less space per employee." (Page PA-229)

### **Supplemental Response:**

- Infrastructure does not have a space reduction policy, but does have a strategy in
  place to reduce leased space by applying our Asset Management Plan. This plan
  focuses on investing in core assets over the long term, right sizing the real estate
  portfolio considering current and future needs, optimizing utilization of assets, and
  disposing of obsolete and inefficient properties.
- From the launch of Infrastructure's Lease Reduction Strategy in 2015-16 to 2018-19, the Ministry has realized annual savings of \$9.1 million and a reduction of 31,829 square metres of space from our portfolio.
- While pandemic related physical distancing measures may not have been specifically identified in developing our standards, these standards are robust enough to consider and account for physical distancing requirements. For example, a minimum resident workstation where staff spend their primary time is allocated space of 6.7 square metres, with dimensions of 2.36 metres by 2.82 metres, which covers the current pandemic recommended physical distancing measure of at least 2 metres.

### 12. Question from Mr. Lorne Dach (NDP), MLA for Edmonton-McClung

#### **Schools**

"Of the 244 schools that were under way in 2018-19, how many are still under way and not completed yet, and how many people are employed currently in the construction of those schools that are currently under way?" (Page PA-229)

### **Supplemental Response:**

- Of the 244 schools that were underway in 2018-19, 46 remain to be completed as of May 31, 2020:
  - o 23 are in planning, design, tender, or contract award;
  - o 13 are in construction and expected to open by the end of 2020; and
  - o 10 are in construction and expected to open by the end of 2021 and beyond.
- These 46 school projects will generate approximately 2,600 jobs in 2020-21.
- The 46 school projects exclude projects that were announced in Budget 2019 and Budget 2020. There are an additional 25 active school capital projects underway that were approved in Budget 2019 and Budget 2020.

# 13. Question from Mr. Lorne Dach (NDP), MLA for Edmonton-McClung

#### **Project Evaluation Using a Climate Change Lens**

"As far as the risk probability idea, are projects evaluated using a climate change adaptation lens like the insurance industry now uses because of the changes in climate? It sort of appears that the 100-year floods are now occurring every seven years, like we had in Fort McMurray, so I'm wondering if the ministry is looking at risk evaluation of projects through a climate change lens." (Page PA-229)

# **Supplemental Response:**

The ministry assesses projects during design, looking specifically at the following:

- Each project is reviewed throughout the design process by Infrastructure's in house technical experts. When reviewing the designs, the engineers and technicians analyze the proposed project's design to determine the resiliency to climate events like fire, flood, wind, and snow;
- The design review process also ensures the projects meet Alberta's building and energy codes. These codes are updated every five years and include updates based on climate change best practices, and
- To support government in building and maintaining facilities with the best current practices to our unique building types, technical design requirements for Infrastructure facilities are maintained. The design requirements are updated based on the latest climate change risks. Compliance by designers with these requirements is required under the designer's contracts and is assessed during the design process. The technical design requirements speak specifically to the ministry's sustainability goals which include facility durability, maintainability, and longevity.

# **Calgary Cancer Centre**

"...I'm wondering if you can inform us about the Calgary Cancer Centre, whether it's still going as planned in 2018-19, if the status is there, what the budget is looking like, any updates to the Calgary Cancer Centre." (Page PA-229)

### **Supplemental Response:**

- The Calgary Cancer Centre continues to be on budget and on schedule.
- The project is on schedule for construction to be completed in 2022 with the facility opening to the public in 2023.

# 15. Question from Ms. Miranda Rosin (UCP), MLA for Banff-Kananaskis

### **Revenue – Government Transfers**

"On Page 33, your statement of revenues has a line for government transfers. The amount from 2018 has been restated to an increase of nearly \$3 million, so I'm wondering if you could explain that." (Page PA-229)

# **Supplemental Response:**

- There were no restatements to Government Transfers revenue in 2018. Rather, the restatements for 2018 figures mainly affected expenses under this column, to reflect government restructurings that were effective April 1, 2018.
  - Government restructuring included transfers, such as the School Facilities Program from Education and Information Management and Technology to Service Alberta.
- Comparatives for 2018 were restated as if the Ministry had always been assigned with its current responsibilities.

### 16. Question from Ms. Miranda Rosin (UCP), MLA for Banff-Kananaskis

#### **Revenue – Tangible Capital Assets**

"On page 33 of the statement of revenue I'm wondering if you can explain the volatility for the gain on disposal of tangible capital assets and the transfer in of tangible capital assets given that the difference between the budget and the actuals for both line items is around the \$20 million mark." (Page PA-229)

### **Supplemental Response:**

- The Transfer in of Tangible Capital Assets revenue was under budget by \$18.5 million.
  - This decrease is primarily due to a change in timing of capital asset transfers from other government entities for projects, such as the Sam Livingston Fish Hatchery and the Alison Creek Brood Trout Hatchery Station, both of which are funded by Environment and Parks.
  - These related party transactions are eliminated in the Government of Alberta consolidated financial statements, which means the transactions do not show up in the consolidated statements. This treatment is in accordance with accounting standards as an organization cannot report transactions that only occur internally.
- There is no budget for Gain on Disposal of Tangible Capital Assets revenue as it is uncertain as to what surplus lands or facilities will be sold, when they will be sold, and what the net proceeds may be. When surplus lands or facilities are sold, the net proceeds, less the book value of the asset, is recorded under "Other Revenue."

# 17. Question from Mr. Richard Gotfried (UCP), MLA for Calgary-Fish Creek

#### **Property Operations Spending**

"Line 4.1 on page 40 of the annual report states the actual spending for property operations. The budgeted amount of \$220 million was exceeded by \$17 million, for a total of \$237 million. Can the department please explain this increase in expenditure?" (Page PA-229)

### **Supplemental Response:**

This increased expenditure is due to additional spending on building maintenance (e.g., building repairs, painting, patch repairs, and consultant investigations), offset by decreased spending in other programs within the department.

# 18. Question from Mr. Richard Gotfried (UCP), MLA for Calgary-Fish Creek

### **Historical Cost Comparison – Long-Term Care and Affordable Housing Projects**

"Can the Ministry provide a historical cost comparison on both long-term care and affordable housing projects on a per-door basis for comparison, going forward, to ensure that we are getting value for dollars in terms of public expenditures on these types of projects?" (Page PA-229)

### **Supplemental Response:**

Responses below have been prepared in collaboration with Health and Seniors and Housing.

- Infrastructure delivers Continuing Care (CC) and Long-Term Care (LTC) facilities
  with projects varying from independent-living apartments and lodges to complex
  acute care auxiliary hospitals or nursing homes. Delivery of facilities includes new
  construction and renovation or rejuvenation projects.
- Alberta Health Services (AHS) delivers health services and defines levels of facility care such as Designated Supportive Living (DSL) and LTC, specifically:
  - ODSL provides a higher level of personal care supports onsite while promoting residents' independence to "age in place." Additional supports at higher levels of care can require secure environments. In addition, some spaces are designated Affordable Supportive Living (ASL) environments where AHS controls access and funds or provides health care. For both DSL and ASL:
    - These beds can be developed by the private, voluntary, or public sectors.
    - The public sector cost per bed is between \$578,000 to \$775,000.
  - LTC is designated specifically for individuals with complex, unpredictable medical needs who require 24-hour onsite assessment and/or treatment. These facilities have on-site physician support, as required.
    - LTC beds can be developed by private, voluntary, or public sector.
    - The public sector cost per bed is between \$370,000 to \$1,040,000, depending on facility requirements and services, such as day programs for non-resident community members.
- Community Housing:
  - In 2018-19, the average cost per space for family and community housing was \$200,000.
  - o In 2018-19, the average cost per space for seniors' housing ranged between \$133,000 and \$182,000.
  - Cost factors included building code and operational (e.g., health service delivery) requirements for supportive living units.

### 19. Question from Mr. Richard Gotfried (UCP), MLA for Calgary-Fish Creek

### Aging Infrastructure – Projects and Evaluations on Sites

"With respect to evaluation of land where aging infrastructure is in place that may be beyond serviceability, what projects and evaluations have been done on sites that might be best suited for redevelopment by either government or in partnership with the private, nonprofit or faith-based sectors?" (Page PA-229)

### **Supplemental Response:**

- Properties with infrastructure beyond a serviceable life are circulated among departments to determine if the property could be used in its current form.
   Departments may consider supported agencies as part of that assessment.
- The assessment can be informed by facility condition evaluations.
- If no Government of Alberta use is identified, municipalities are asked if they have a public need for the property.
- If municipalities identify no public need, surplus properties are listed for public sale and all sectors, (including private, non-profit, and faith-based sectors) have an opportunity to acquire the site from government.
- Government can also use Expressions of Interest or market soundings to evaluate outside opportunity for more complex sites. For example, a Request for Expression of Interest is currently open (closes July 31, 2020) exploring private financing investment in the development of public properties including the former Downtown Remand Centre, Former Royal Alberta Museum – Glenora, Harcourt House, and Warehouse 3.

# **Guideline: Capitalizing Staff Salaries**

(Last Reviewed and Updated: April 1, 2018)

#### Overview

The purpose of this guideline is to provide clarification regarding the capitalization of salaries, benefits and other employment costs for staff, as approved by Executive Team. This policy is effective April 1, 2016, and will be applied prospectively without restatement. It cannot be applied retroactively as the necessary financial data is not reasonably determinable.

This guideline is intended to supplement the Government of Alberta (GOA) <u>Capital Asset Policy</u>. It should be noted the guideline is not all-inclusive and cannot address every situation so professional judgment must be exercised in its application. Finance should be consulted for support as required.

#### **Definitions**

To consistently apply and understand the guideline, a number of definitions have been established, based on accounting standard PS3150 Tangible Capital Assets and the GOA Capital Asset Policy.

**Tangible Capital Assets** – non-financial assets having physical substance that are held for use by government in the production or supply of goods and services, for rental to others, for administrative purposes or for the development, construction, maintenance or repair of other tangible capital assets. These have useful lives extending beyond a year, are intended to be used on a continuing basis, and are not intended for sale in the ordinary course of operations.

**Capital Project** – any projects that result in a tangible capital asset.

Capital Cost — the cost of a tangible capital asset includes the gross amount of consideration given up to acquire, construct, develop or better the asset, and includes all costs directly attributable to acquisition, construction, development or betterment of the asset, including installing it at the location in the condition necessary for its intended use. This could include costs such as design, engineering fees, legal fees, survey costs, site preparation costs, freight charges, and duties. The cost of a constructed asset would normally include direct construction or development costs (such as materials and labour) and overhead costs directly attributable to construction. The activities necessary to prepare an asset for use encompass more than physical construction. They include the technical and administrative work prior to and during construction. Interest costs are not part of the Capital Cost, except for P3 projects.

**Directly Attributable** – incurred specifically for a capital project(s). For Infrastructure, this <u>includes</u> <u>project staff positions that spend at least 70% of their time on the delivery of capital projects</u>. The 70% threshold is based on that used by other similar departments within GOA to strike a reasonable balance to capture the true cost of the capital asset. It does not include positions that only support the delivery of projects by providing management advisory or support services, or general administration.

**Project Staff** – staff in areas that are directly engaged in delivery and responsible for carrying out capital project activities. This includes Health Facilities, Government Facilities, and Learning Facilities.

**Support Staff** – staff in areas that assist in carrying out capital project activities. This includes some staff in Procurement and Cost Management, Technical Services, and Operations and Administration.

#### **The Guideline**

Public Sector Accounting Standards (PS3150) allow for staffing and other overhead costs to be legitimate costs of a capital project if the costs are directly attributable to the project. This includes salary and all forms of benefit in exchange for service rendered.

The main objectives of capitalizing costs for tangible capital assets are:

- To maintain appropriate accountability for government's assets;
- To measure and report the full cost of government operations and capital assets;
- To ensure efficient and effective use of assets, and
- To ensure accounting consistency across government.

Capitalization of costs should begin when the preliminary project stage is complete and government has authorized and made a commitment to fund the project (generally, Treasury Board approval) and it is probable the project will proceed. In this context, when you consider the stages of a project lifecycle, the following describes the typical treatment of certain types of activities:

- Pre-project Planning, Strategizing, Assessments, Feasibility Studies EXPENSE
- Project Definition, Design of Chosen Path, and Start Up CAPITALIZE
- Consultant Selection, Tendering and Award CAPITALIZE
- Planning, Design and Construction CAPITALIZE
- Commissioning and Warranty CAPITALIZE
- Post-Completion, Evaluation and Close EXPENSE or CAPITALIZE
- Audit, Quality Assurance and Reporting EXPENSE
- > Training, Organizational Change, Ongoing Support and Maintenance EXPENSE

In general, most costs after a project is completed and put into use are expensed, unless they continue to add to the functionality or useful life of the asset. If a project is abandoned at any time, all related costs incurred to that point should be expensed, as well as any going forward.

Manpower costs for project staff determined to be 'directly attributable' (over 70%) to capital projects based on the activities described above should be capitalized and appropriately allocated to projects based on executive assessment of how resources are deployed. The cost associated with a more detailed approach to tracking and allocating this staff time outweighs any benefit, and would not be reasonable in the absence of a sophisticated time tracking system.

Manpower costs for support staff are capitalized based on an estimate of their actual time spent assisting with capital type activities in the delivery of capital projects.

Documentation with rationale should be retained to support the evaluation of staff as directly attributable to capital projects, including the general nature of the positions and a financial audit trail of their costs.

The capitalization of staff and the related allocation to projects should be regularly reviewed. The guideline should be regularly reviewed for appropriateness and consistency within government.
