#### I. INTRODUCTION

The mandate of the Standing Committee on Public Accounts is to review the Public Accounts of the Province of Alberta (Ministry Annual Reports) by asking questions with respect to expenditures in Government Departments, and to review the Auditor General's annual and other reports.

The Standing Committee on Public Accounts comprises a Chair who is a Member of the Official Opposition, a Deputy Chair who is a member of the Government Caucus, 11 Government Members, three Liberal Opposition Members, and one New Democrat Member.

The Public Accounts of Alberta are prepared in accordance with the *Financial Administration*Act and the Government Accountability Act. The Public Accounts consist of the Annual Report of the Government of Alberta and the annual reports of each of the 20 Ministries.

The 2005-2006 and 2006-2007 Annual Reports of the Government of Alberta contain an accountability statement and the consolidated financial statements of the Province. The *Measuring Up* report provides a comparison of the actual performance results and the desired results as set out in the Government's business plan.

The annual reports for the Ministries for the years ended March 31, 2006 and March 31, 2007 contain Ministers' accountability statements, the audited consolidated financial statements of the Ministries, and a comparison of actual performance results and the desired results set out in the Ministries' business plans.

### **II. COMMITTEE ACTIVITIES**

In 2007 there were several changes made to the scope and mandate of the Standing Committee on Public Accounts. A House Leaders' Agreement signed on March 7, 2007 made changes, which will continue to be in effect for the remainder of the current Legislature.

- The mandate of the Public Accounts Committee shall be expanded and include reviewing and reporting on the Public Accounts of Alberta, all reports of the Auditor General of Alberta and any other matter referred to it from time to time by the Legislature. Its mandate extends to all public entities funded by Government including agencies, commissions and regional health authorities.
- The Committee may call and question Ministers, senior department officials or officials of agencies, boards and commissions of Government and such others as may be necessary for the full pursuit of its duties.

These changes are important, since the Committee had previously met only with Ministers of the Crown.

• The Committee shall set its own agenda and may sit whether or not the House is in session.

Previously the Committee did not have the budget to meet outside of session.

 Necessary resources will be provided for staffing to ensure adequate support for the Committee's expanded mandate.

The Committee now has an in-house Research Coordinator, who looks after research requirements, including Committee briefing materials.

## II. COMMITTEE ACTIVITIES (continued)

 All reports of the Auditor General shall stand permanently referred to the Public Accounts Committee.

Previously these reports were used by the Committee in its work, but they were not automatically referred to the Committee.

 The Committee may report to the House, and the Government shall respond to a report of the Public Accounts Committee within 150 days of the date on which the Committee reports.

Previously there was no requirement for the Government to respond to the Committee's recommendations.

Another change to note this year has been that Deputy Ministers and departmental officials have appeared before the Committee without the Minister in attendance.

The Auditor General and his staff continued to attend and participate in all Committee meetings, as well as assist with Committee briefing sessions. Committee members appreciate the Auditor General's advice and input as they work through procedural changes.

During the Spring 2007 sitting of the Alberta Legislature, the Public Accounts Committee held an organizational meeting and 10 meetings with Ministries on the 2005-2006 Public Accounts and the 2005-2006 Auditor General's Report.

The 2006-2007 Annual Report of the Government of Alberta was released in June.

The Ministries' annual reports for 2006-2007 were released in September. According to Temporary Standing Order 53(1) in effect for the 26<sup>th</sup> Legislature, these documents - and all reports of the Auditor General - are automatically referred to the Public Accounts Committee.

The Report of the Auditor General for the fiscal year ended March 31, 2007 was released in October.

The Committee held out-of-session meetings with four regional health authorities in September and four universities and colleges in October: East Central Health, Northern Lights Health Region, Capital Health, Calgary Health Region, Mount Royal College, Grant MacEwan College, University of Alberta, and University of Calgary.

During the Fall 2007 sitting of the Alberta Legislature, the Public Accounts Committee held four meetings on the 2006-2007 Public Accounts and the 2006-2007 Report of the Auditor General. This brought the number of meetings held in 2007 to 23, compared with 12 meetings in 2006.
