1.0 Introduction

The Standing Committee on Health (the "Committee") met on three occasions in November 2008 to hold public meetings pursuant to Standing Order 52.08(1). This Standing Order provides:

52.08(1) A Policy Field Committee may hold public meetings on any matter within its mandate.

The Committee heard from a variety of presenters, including seven organizations, one individual, and the Department of Health and Wellness. In the first public meeting, held on November 3, 2008, the Committee heard from the Honourable Ron Liepert, Minister of Health and Wellness, and Dr. Gerry Predy, Acting Chief Medical Officer of Health. This meeting was initiated following the approval of a motion by the Committee on September 10, 2008:

MOVED by Dr. Sherman that the Standing Committee on Health request the attendance of the Minister of Health and the Acting Medical Officer of Health to respond to questions related to the delivery of public health to Alberta.

The final two meetings dealt with a variety of issues within the Committee's mandate. Section 2.0 of this report lists those who presented at the meetings and the topics of their presentations.
