1.0 INTRODUCTION

Bill 201, Protection of Students with Life-threatening Allergies Act, was introduced and received first reading on May 30, 2019.

2.0 ORDER OF REFERENCE

Pursuant to Standing Order 74.11:

- (1) After a public Bill other than a Government Bill has been read a first time, the Bill stands referred to the Private Bills and Private Members' Public Bills Committee.
- (2) The Private Bills and Private Members' Public Bills Committee shall report back to the Assembly within 8 sitting days of the day on which the Bill was referred to the Committee.

Pursuant to Government Motion 11, Part B

And be it further resolved that upon passage of this motion any public Bills other than Government Bills that stand on the Order Paper for second reading are deemed referred to the Standing Committee on Private Bills and Private Members' Public Bills in accordance with Standing Order 74.11(1) and notwithstanding Standing Order 74.11(2) the Committee shall report back to the Assembly on these Bills within 12 sitting days of the day this motion is passed.

3.0 COMMITTEE ACTIVITIES

As part of the Committee's review of Bill 201, Committee meetings were held on June 4 and June 11, 2019. The sponsor of Bill 201, Jackie Armstrong-Homeniuk, Member for Fort Saskatchewan-Vegreville, gave a presentation on the Bill to the Committee on June 11, 2019.

4.0 RECOMMENDATIONS

Pursuant to Standing Order 74.2, the Standing Committee on Private Bills and Private Members' Public Bills Committee recommends

that Bill 201, Protection of Students with Life-threatening Allergies Act, proceed.
