1.0 INTRODUCTION

Bill 207, Reservists' Recognition Day Act, was introduced and received first reading on November 18, 2020.

2.0 ORDER OF REFERENCE

Pursuant to Standing Order 74.11:

- (1) After a public Bill other than a Government Bill has been read a first time, the Bill stands referred to the Private Bills and Private Members' Public Bills Committee.
- (2) The Private Bills and Private Members' Public Bills Committee shall report back to the Assembly within 8 sitting days of the day on which the Bill was referred to the Committee.

3.0 COMMITTEE ACTIVITIES

As part of the Committee's review of Bill 207 a Committee meeting was held on November 24, 2020. At that meeting the sponsor of Bill 207, Brad Rutherford, Member for Leduc-Beaumont, made a presentation on the Bill to the Committee. Another Committee meeting was held on December 1, 2020, to complete deliberations on Bill 207.

4.0 RECOMMENDATIONS

Pursuant to Standing Order 74.2 the Standing Committee on Private Bills and Private Members' Public Bills recommends

that Bill 207, Reservists' Recognition Day Act, proceed.
