1.0 INTRODUCTION

Bill 217, Polish-Canadian Heritage Day Act, was introduced and received first reading on May 27, 2021.

2.0 ORDER OF REFERENCE

Pursuant to Standing Order 74.11:

- (1) After a public Bill other than a Government Bill has been read a first time, the Bill stands referred to the Private Bills and Private Members' Public Bills Committee.
- (2) The Private Bills and Private Members' Public Bills Committee shall report back to the Assembly within 8 sitting days of the day on which the Bill was referred to the Committee.

3.0 COMMITTEE ACTIVITIES

As part of the Committee's review of Bill 217 a Committee meeting was held on June 1, 2021. At that meeting the sponsor of Bill 217, Dan Williams, Member for Peace River, made a presentation on the Bill to the Committee, and the Committee completed deliberations on Bill 217.

4.0 RECOMMENDATIONS

Pursuant to Standing Order 74.2 the Standing Committee on Private Bills and Private Members' Public Bills recommends

that Bill 217, Polish-Canadian Heritage Day Act, proceed.
